



Teelin Feis/Michael Berry Memorial Feis and Music Festival VENDOR CONTRACT

This agreement dated _____ is made between The Teelin School of Irish Dance, herein referred to as 'Feis Committee,' and the contracted, as 'Vendor.'

VENDOR SERVICES: The Feis Committee hereby authorizes the Vendor to perform the following services in accordance with the terms and conditions set forth in this agreement. The vendor will consult with the Feis Committee vendor representative, Erin Jacobs, on any matters related to that Vendor's participation in the events.

TERM OF AGREEMENT: This agreement will begin on **November 4, 2023, and end on November 5, 2023.** **Either party may cancel this agreement without penalty prior September 14, 2023. After September 15, 2023, the vendor fee will be non-refundable.** Cancellation notice must be sent to, feis@teelin.com. Notice will be acknowledged upon receipt by e-mail. TIME DEVOTED BY THE VENDOR: It is anticipated that the Vendor will spend approximately one full day fulfilling the Vendor's obligation under this contract. Vendors will have access to setup their areas on November 3, 2023 after 6:30pm or after 6:30 am the morning of the Feis. Vendors must be set up and be ready prior to the beginning of the dancing portion of the Feis at 8:00 am on Saturday November 4, 2023. Vendor will be open during the entire duration of the Feis, and shall not close down prior to 4:00 pm on Sunday November 5, 2023 or the end of the Feis, whichever comes first.

FEIS LOCATION: The Vendor will perform its service in accordance with this contract at the **Maryland State Fairgrounds**, located at 2200 York Rd, Timonium, MD 21093. Vendor location will be in the center hall near the awards area.

VENDOR FEE: The Vendor pays a \$200 registration fee for 2 tables or \$275 for 4 tables per day and Feis Committee will include a company link on the Feis website. Vendor fee is due at the time this contract is submitted. Request for electricity requires an additional \$50 fee. A \$100 discount is given if attending both days as a vendor. INDEPENDENT VENDOR: Both the Feis Committee and the Vendor agree that the Vendor will act as an independent contractor in the performance of its duties under this contract. Accordingly, the Vendor shall be responsible for payment of any and all taxes, including Federal, State and Local tax. Vendor is also required to carry their own liability insurance coverage.
